NY Green Bank (NYGB) is hosting a public Stakeholder Forum in connection with the modified version of the Metrics, Reporting & Evaluation Plan (Metrics Plan) that is required to be filed by June 20, 2016 pursuant to the “Order Authorizing Clean Energy Fund Framework” issued by the Public Service Commission on January 21, 2016.

The Stakeholder Forum is intended to provide interested parties with an opportunity to discuss with NYGB proposed revisions and modifications to the Metrics Plan and will be held both in-person and by webinar, with in-person attendance available for a limited number of participants on a “first-come, first-served” basis. Please include only one person from your organization for the in-person session so all interested parties have adequate opportunity for in-person representation. This meeting will also offer an opportunity for stakeholders to ask clarifying questions (which can be submitted electronically during the discussion for webinar attendees) on the information presented and offer comments and feedback for consideration as NYGB prepares the updated Metrics Plan version 3.0. Please note that questions and comments will be moderated in order to accommodate as many participants as possible, but all questions and comments submitted will be considered by NYGB in revising the Metrics Plan.
